General Eligibility Requirements

Applicants must:

- Be medically fit for employment.
- Have a good command of the English language.
- Meet the specific requirements for the advertised position.

Specific Requirements for the Scientific Research Assistant Position

Applicants must:

- Hold a Bachelor's degree in **Chemistry, Biochemistry, Physics, or a related field**, as well as a Master's degree in one of the same fields.
- Possess solid knowledge of chemistry or physics.
- Knowledge of **quantum chemistry, quantum mechanics, classical mechanics and/or statistical physics** will be considered an advantage.
- Be enrolled, or be willing to enroll, in a **PhD programme in Computational Chemistry**.
- Be willing to travel both nationally and internationally.
- Be highly motivated, creative, and possess excellent communication and teamwork skills.
- Demonstrate proficiency in English (mandatory).

Application File

The application file must include the documents required by **Law No. 183/2024 on the Status of Research, Development and Innovation Personnel**, namely:

- Application letter addressed to the ICMPP management requesting participation in the competition.
- Copy of the identity document and copies of documents certifying any change of name, where applicable.
- Copies of Bachelor's and Master's degree diplomas, together with academic transcripts.
- Copy/extract from the General Register of Employees (Revisal) proving previous employment experience, where applicable.
- Curriculum Vitae tailored to the requirements of the position.
- List of scientific contributions, accompanied by supporting documents, where applicable.
- Motivation letter (free format) explaining the applicant's motivation for applying.
- Original medical certificate confirming the applicant's health status, issued according to the standard format established by the Romanian Ministry of Health.
- Criminal record certificate or a declaration on one's own responsibility stating that the applicant has no criminal convictions incompatible with the position, with the obligation to submit the original criminal record certificate no later than the date of the first examination.
- GDPR Declaration.
- An essay on the required topic presenting the applicant's personal development plan, based on previous university activities (Bachelor's and Master's studies), and explaining how their knowledge supports future doctoral studies in Computational Chemistry. The essay must not exceed **three (3) pages** and must be written **in English**.

Selection Procedure

1. Application Screening

The Competition Committee will assess the eligibility of the submitted applications.

Failure to submit any required document or to meet any mandatory eligibility criterion will result in disqualification.

Applications will be assessed as **Admitted** or **Rejected**.

2. Written examination¹

The written examination will be conducted **online** and will consist of the evaluation of the essays submitted with the application.

Each member of the Competition Committee will independently award a score from **1 to 10**.

3. Interview

The interview will be conducted **online**.

Each member of the Competition Committee will independently award a score from **1 to 10**. The final score will be the arithmetic mean of the scores awarded by all committee members. Candidates will be ranked according to their final average score.

Responsibilities of the Selected Candidate

Scientific Research Activities

- Multi-scale **in silico** design and study of non-viral vectors for gene therapy, including structural characterization, interaction of non-viral vectors with complementary polymer sequences and specific genetic molecules (DNA/RNA), and polyplex interactions with cellular membranes.
- Synthesis of systems designed through **in silico** studies and their characterization using physicochemical methods to validate input-output computational chemistry models.
- Evaluation of potential applications and development of new investigation tools.

Dissemination Activities

- Dissemination of research results through publications in **Web of Science (ISI)-indexed journals** and presentations at national and international scientific conferences.
- Contribution to the preparation of research reports.

Sustainability Activities

- Participation in training courses related to attracting and managing additional research funding.
- Identification of and application to competitive funding programmes to ensure the long-term sustainability of the candidate's research activities and those of the research group.

Support Activities

- Assisting in the organization of the laboratory workspace to ensure efficient and safe research activities.
- Assisting in the storage and management of consumables and chemical reagents required for research activities.
